**SECTION 4 — FIRST AID MEASURES**

**GENERAL ADVICE:** First Aid responders should pay attention to self-protection and use the recommended protective clothing (chemical resistant gloves, splash protection). If potential for exposure exists, refer to Section 8 for specific personal protective equipment.

## SECTION 6 — ACCIDENTAL RELEASE MEASURES

**SPILL AND LEAK RESPONSE AND ENVIRONMENTAL PRECAUTIONS** Uncontrolled releases should be responded to by trained personnel using pre-planned procedures. Proper protective equipment should be used. In case of a spill, clear the affected area, protect people, and respond with trained personnel.

**PERSONAL PROTECTIVE EQUIPMENT** The proper personal protective equipment for incidental releases (such as: 1 Liter of the product released in a well-ventilated area), use impermeable gloves (triple-gloves (rubber gloves and nitrile gloves, over latex gloves), goggles, face shield, and appropriate body protection. In the event of a large release, use impermeable gloves, specific for the material handled, chemically resistant suit and boots, and hard hat. ## SECTION 7 — HANDLING AND STORAGE

**HANDLING** Isolate from oxidizers, heat, & open flame. Use only with adequate ventilation. Avoid breathing of vapour or spray mist. Avoid contact with skin & eyes. Wear OSHA Standard goggles or face shield. Consult Safety Equipment Supplier. Wear goggles, face shield, gloves, apron & footwear impervious to material. Wash clothing before reuse.
